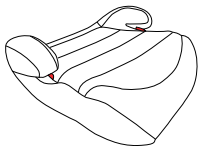


# Child Safety Car Seat Instruction Manual



Type:TAMBU,TAM001  
Group:III  
Weight:22-36kg  
(Approximately 6-12 years)

## NOTICE

-This is a “universal” child restraint. It is approved to Regulation No.44.04 series of amendments, for general use in vehicle and it will fit most, but not all vehicle seats.

A correct fit is likely if the vehicle manufacturer has declared in the vehicle handbook that the vehicle is capable of accepting a “universal” child restraint for this age group.

-This child restraint has been classified as “universal” under more stringent conditions than those which applied to earlier designs which do not carry this notice.-

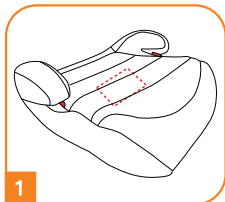
If in doubt, consult either the child restraint manufacturer or the retailer.

**Only suitable for use in the listed vehicles fitted with 3 point retractor safety belts, approved to ECE Regulation No. 16 or other equivalent standards.**

Thank you for purchasing the Cozy N Safe Tambu booster seat.  
To ensure the seat works as intended and gives the best possible protection for your child, the seat must be used exactly as described in this manual.

Please read this instruction manual carefully before use. It is important that these instructions remain with the car seat at all times.

You can store these instructions under the seat cover (fig.1)



## General safety instructions

If it's the first time using the child restraint system, please read the entire instruction manual thoroughly before installation. Improper installation can endanger the life of your child.

Ensure your child and the car seat are installed correctly before each trip. Do not attempt to make any adjustments while driving.

"Only suitable if the approved vehicles are fitted with 3 point retractor safety-belts, approved to UN/ECE Regulation No. 16 or other equivalent standards."

The rigid items and plastic parts of a child restraint must be so located and installed that they are not liable, during everyday use of the vehicle, to become trapped by a **movable seat** or in a door of the vehicle;

Airbags can cause injury. Do not use this child seat on a passenger seat fitted with **an active frontal airbag installed**.

Any straps holding the restraint to the vehicle should be **tight**, any straps restraining the child should be adjusted to the child's body, straps should not be **twisted**;  
It is very important to ensure the lap strap is worn low down, so that the pelvis is firmly engaged.

The child restraint system should be changed when it has been subjected to violent stresses in an accident. Do not make any alterations or additions to the device without the approval of the competent authority. Always follow closely the installation instructions provided by the car seat manufacturer.

When the child restraint system is not provided with a **textile cover**, it shall be recommended that the chair should be kept away from **sunlight**, otherwise it may be too hot for the child's skin;

Never leave your child **unattended** in the child restraint system.

Any **luggage** or other objects liable to cause injuries in the event of a collision shall be properly secured.

**PLEASE READ THOROUGHLY BEFORE COMMENCING INSTALLATION. AS AN INCORRECT INSTALLATION COULD BE DANGEROUS**

The safety **belt buckle** is not fully tamper proof and therefore your child should be taught to never play with it.

It is important to ensure that the lap strap is worn low down as this secures the pelvis. The rigid items and plastic parts of a child restraint must be located and installed so that they are not liable during everyday use of the vehicle to become trapped by a movable seat or in a door of the vehicle.

Remove the **headrest** of the vehicle seat being used, if it causes an obstruction for proper installation of the seat, but do not forget to refit the headrest after use.

The correct use and maintenance of your car seat will ensure it gives long and trouble free use. When somebody else is using your car seat, ensure they also know how to use it, especially the correct way to **adjust it**.

The rigid part of vehicle buckle must be lower than the main bear point (The route guide located under the armrests (red tag)).

The buckle should not interfere with the belt guides.

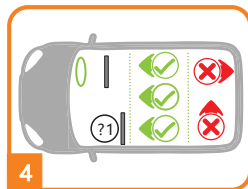
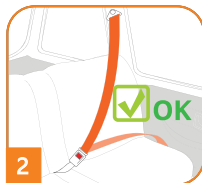
### Seat for universal installation for (Gr.III)

The child restraint system can be installed in vehicles on any seat suitable for use in the listed vehicles fitted with 3 point retractor safety-belts, approved to ECE Regulation No. 16 or other equivalent standards. **(Fig. 2)**

And **MUST NOT** at any time be fitted using only a 2 point lap belt. **(Fig. 3)**

If the car manufacturer allows child restraint systems on the passenger seat, the seat should be moved to the position furthest back. **(Fig. 4)**

We suggest to always install this child seat in the rear seats of the vehicle. This will be safer for your child.



## Seat installation

The seat can be used only forward facing at Group III.

1. Put the child seat on the vehicle seat, make sure the backrest is pressed firmly against the vehicle seat backrest.

2. Let your child sit on the child seat, make sure your child's back just against vehicle seat backrest.(fig.5)

3. Extend the vehicle belt long enough to allow the belt to move around in front of your child. And insert the buckle tongue into the vehicle buckle, until you hear a "click".(fig.5)

4. Adjust the diagonal belt against your child's shoulder (fig.6)

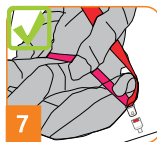
5. Adjust the vehicle belt lap section. It is important that any lap strap is worn low down, so that the pelvis is firmly engaged.

6. Pull the diagonal belt at the top of the vehicle buckle to make the belt tight.(fig.6)

7. Then pull the diagonal belt at the top of the seat as indicated as tight as you can.(fig.6)

8. Finally check the child seat is fixed & stable on the vehicle seat. If you find any movement, tighten the belt again until the child seat no longer moves.

The correct belt route is shown in (fig.7). The image in (fig.8) is an incorrect route. The diagonal belt should go ABOVE the armrest. You can contact the manufacture if you are unsure about this point.



### Important:

The seats optimum safety characteristics can only be achieved if it is used properly according to the installation instructions.

Do not modify the child restraint system. All belts must lie tightly against the child's body without being twisted.

Luggage and other objects should be stored properly in the event of an accident, these can be dangerous and can injure your child.

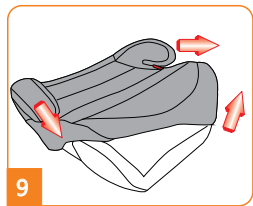
## Removing and replacing the cover

The fabric cover on this seat can be removed for washing, simply pull it off at the fringe of the seat (fig.9). After washing you can recover the seat again.

The seat cover is an integral part of the child seat, the child restraint must not be used without the cover.

The seat cover should not be replaced with any other cover than the one recommended by the manufacturer, this is because the cover constitutes as an integral part of the restraint performance.

**To replace the cover, follow the steps for removing the cover in reverse order**



## Washing and maintenance

Check if there is any part missing or broken, if this is the case, do not use the seat again.

### Fabric:

Fabric can be washed at 30°C or less, then leave to air dry. Do not tumble dry.

### Belt and plastic:

Wash fabric with warm water and mild soap, do not use solvents or high-potency soap.

Do not remove, move or change fabric from the original fabric or any part.
